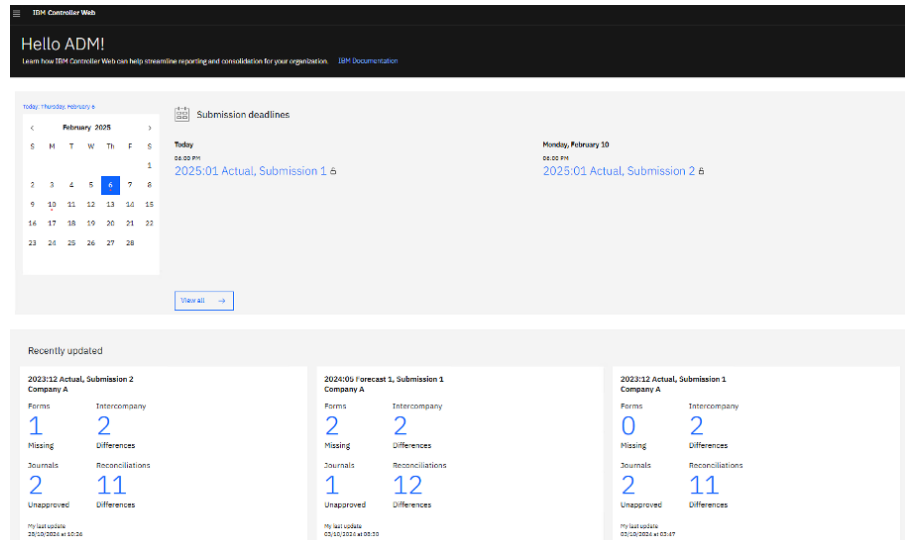


Figure 1: The home page provides an intuitive web user experience with upcoming deadlines.

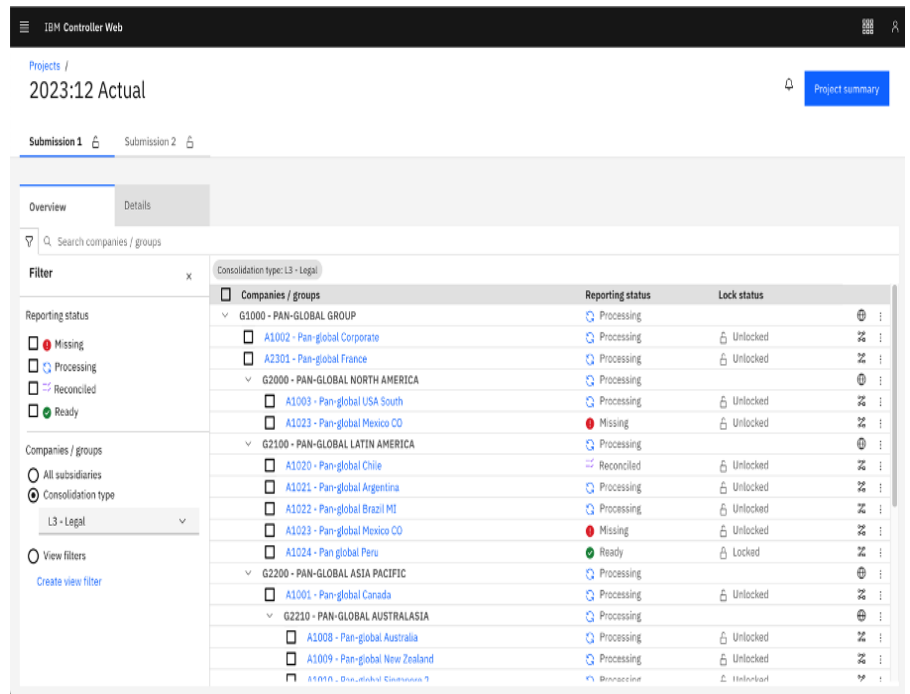


Figure 2: The project overview is an easy-to-use web interface for managing the close process and access the reporting status of each entity.

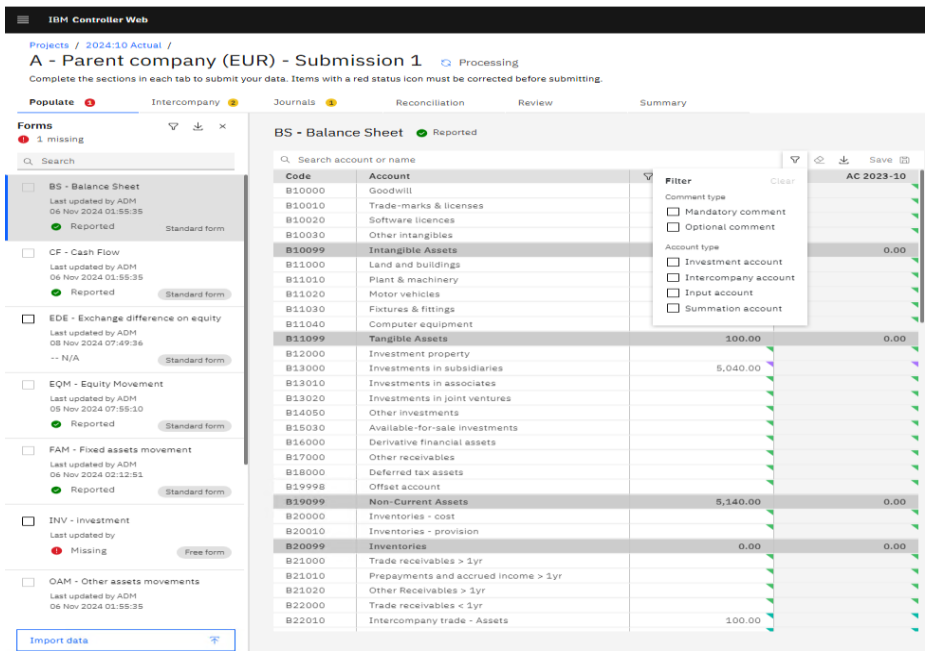


Figure 3: The company workflow is an intuitive web user experience for reporting sites to complete their tasks efficiently.
